She has been incorporating the artistry of Trauma-Sensitive Yoga both individually with clients, and in the group setting for the past several years. She was one of the first practitioners in the Cedar Valley to be trained in Trauma-Sensitive Yoga. She believes in offering her colleagues and clients cutting-edge, evidenced-based modalities for treating the body and mind that augment clinical practice. She has extensive clinical supervision mentoring social work supervisees seeking independent licensure emphasizing the administrative, supportive, and educational functions of clinical social work practice.

Jenny Becker, LISW, is the current Director of Field Instruction at the University of Northern Iowa's Department of Social Work. Jenny has 18 years of experience working in various child welfare settings, obtaining her LISW in 2001 conducting individual, family and group clinical therapy at the Mental Health Institute in Independence, Iowa. Jenny currently serves as a community advisory board member with the Child Protection Center in Waterloo and assisted in developing the Cedar Valley Mental Health Connections website, a tool used by individuals and family members impacted by mental health issues.
